The national flag of India is a horizontal tri-colour of deep saffron at the top, white in the middle Ashoka Chakra / Navy Blue Colour Wheel with 24 Spokes and dark green at the bottom. ... The saffron colour indicates the strength & courage of the country. The white indicates peace & truth. The green band represents the fertility, growth, & auspiciousness of our land. – The shape of the emblem is of Torch Flame (something that gives light or guidance, and pass the torch of Sports Values & traditions to next generation.)
